2) Refund Notice

a) Was going to send a letter as follows:

Dear CCA member,

As we all know, our curling season is shorter this year primarily due to the late date that the ice was installed. As you probably know, our curling ice uses De-ionized water which must be ordered well in advance of when we start .ate. Then, we had our Grand Slam event which delayed our start by another week. Keep in mind that the Grand Slam event was always going to be a non-curling week, so no additional scheduled curling time was lost.

Without the ice in place, the CRCA did not charge us for the missed ice time, so our costs were done proportionally. As a result, the Chestermere Curling Association board has agreed to offer a refund to each paid up member in the amount of \$40.00 per league that the member is registered as a team member (skip, vice, 2nd, lead). Although we were able to accept payment for registration by eTransfer, our bank account does not permit sending our eTransfers. Therefore, our only form of refund is a cheque.

For those who wish to receive a refund, please email your request to <u>info@chestermerecurling.com</u> no later than March 4th, 2022. Please use the subject line "2022 Refund Request" and the league(s) that you are registered in. The league coordinator will try to get you a cheque during one of your playoff games. If that is unsuccessful then we can try at our windup party on March 26, and if that too fails, we will mail it to you.

For those who instead are content with donating the refund back to the CCA, I would like to thank you, and be assured that the money will be put to good use in future seasons.

Avery will email Nick some suggested amendments to refund email, prior to sending out to Members.

3) Brian Nociar changing his availability

a) After years of Brian and Trevor building and maintaining our ice, they would like to reduce their commitment to the CCA.

Trevor will take over the lead in the New Year. Brain will continue to help in a reduced capacity, as a consultant. Brain indicated that Trevor is not interested in dealing with the school cleaning. Trevor will require assistance to build & maintain the ice next year. Katherine suggested that an email be sent out to membership asking if anyone is interested in learning & helping with the ice maintenance, for next year. Training would be provided. Nick will add this to the refund email.

4) Senior Curling

- a) Rod Trickey coordinates and prepares the ice for senior curlers. There have been some scheduling conflicts with the schools and the times that the seniors can play (schools using ice before seniors). This has resulted in some senior games being moved to Friday.
- b) Next year Rod would like to have seniors begin all games at 9:00 so it would be before the schools come.

Rod indicated that he has not yet consulted with the Seniors regarding a change in the start time. The preferred solution, to avoid time conflicts with the schools, would be to request that the CRCA does not schedule any Schools on Thursday mornings. This will have to be addressed with the CRCA for next year.
