## **New Business**

#### **Chestermere/Indus Modified Mixed Bonspiel**

a) 28 Teams Registered which is what we had last year, this year we have 3 Teams on the waitlist which is very comforting.

#### 2) Monday Men's league Issue

- a) January 6<sup>th</sup>, Sheet 1 was to be Hummel vs Wolf, and sheet 2 was to be Hamel vs D'Amico. What actually was played was Sheet 1 was D'Amico vs Wolf, and sheet 2 was Hamel vs Hummel (Hummel and D'Amico were on the wrong sheets). A roster adjustment will need to be made.
- b) We had a lengthy discussion of several possibilities to help try to alleviate the problem, such as holding back-to-back games for these teams to make-up the games that were missed when the ice was available etc. But this problem was too convoluted for us to come up with a satisfactory plan.
- c) Our decision is: The two teams that were on the correct sheets on that night are to be given the "W", and the two teams who were on the incorrect sheet are to be given an "L" for that nights games. This way the schedule can be followed for the remainder of the season without any changes. Also we do have a rule that there are no make-up games allowed.
- d) An email will be sent to our curling membership letting everyone know to pay close attention to which sheet their game is on using the schedule on the curling bulletin board, and the result going forward will always be that the team on the correct sheet will be given the Win if playing another team who is on the wrong sheet. This will be added to the rules in our curling booklets for future seasons.

#### 3) Calgary & Area City Championship

a) No Details currently. The Calgary and Area Managers will be having a meeting in the near future, Marla will keep us posted.

#### 4) Roster Changes

a) Deadline for roster changes is February 1, 2025, as per the booklet. Updates will be posted on the curling bulletin as they occur.
